Wigan Canoeing Group - General Data Protection Regulation (GDPR)

New EU legislation comes into force on 25/5/18 which changes the way organisations handle and process data. The UK is implementing a new Data Protection Bill which largely includes all the provisions of the GDPR. There are some small changes but our own law will be largely the same.

Wigan Canoeing Group takes your privacy seriously. We will only use your data to administer your account. All personal information held by WCG is stored either in a locked filing cabinet in the training room at Scotmans Flash or on the password-controlled computers of certain club committee members. Access is currently limited to members of the Club Committee. The club undertakes to take all reasonable steps to keep this information secure and will not disclose any personal information to third parties.

To assist the club in implementing this new legislation we need your permission to archive your personal data for a minimum of 3 years.

How your information will be used:

We will only retain your data for as long as we need to administer your membership.
